4. Fees of children enrolled under RTE rules as described in Clause 3 will be released by the Government as per rules. So it has been decided to collect any festival from these children.

5. The school and the school management are prohibited from collecting any harachara capitation fee and voluntary watering bonus from the parents in any manner during Rajarati or hybrid.

6. The information of the fee charged by the school/board to the parents of the children in their school as per State Government Notification No.E03-PGC 2019 Dated:27.07.201 will be published on the departmental website and on the school notice board.

No fee shall be charged in excess of the prescribed fee for grading.

7. The School / Governing Body shall enroll the students within the period prescribed by the Government

8. The school / governing body cannot refuse enrollment against the following factors.

(i) Due to lack of age

(ii) On the basis of caste, religion, place of birth, language.

(iii) If admission is sought after the extended period of admission.

9. Carrying out all safety measures as per RTE Act and Rules, Karnataka Education Act and Rules Fire Safety and Building Safety Certificate from concerned authorities and safety of learning of children as per K.S.C.P.C.R and N.C.P.C.R.

10. The School / Governing Body as follows:

(i) No admitted child shall be retained in any class or expelled from the school till he completes primary and secondary education in the school.

(ii) No child shall be physically or mentally abused

(iii) No child is required to pass any board examination till completion of primary education:

(iv) Every child who completes primary education is issued a certificate as prescribed under RTE Rule-21 and Karnataka Education Act and Rules.

(v) As per the provisions of the RTE Act and Rules and the Karnataka Education Act and Rules the school shall also admit children with special needs / special children.

(vi) Appointed teachers should possess minimum qualifications as prescribed for primary and high school teachers in RTE Act and Rules and Karnataka Education Act and Rules and Government Orders.

(vii) Salary and Allowances payable to teachers and terms and conditions of service shall be as prescribed by the State Government and through Government Notification [Provided Fund (Pe) and Bank and other emoluments payable to teachers shall be paid and subject to Employee State Insurance (ESI).

(viii) Teachers shall perform the duties prescribed under Section-24[1] of the Act and the RTE Act and Rules and Rule-17 of the Karnataka Education Act and Rules and shall not engage themselves in private tuitions for supervisory considerations.
